IT IS HEREBY ORDERED THAT:


1. In accordance with section 14 (10) of the Terrorism Prevention Act,

 - b. All Orders previously issued by this Court in respect of the below mentioned listed entities shall cease to apply to said entities as of 9th June 2025.
